Countries with LASALLE representatives are Brunei, Cambodia, China, Hong Kong, India, Indonesia, Kyrgyzstan, Malaysia, Myanmar, Philippines, South Korea, Thailand and Vietnam.

Our appointed overseas representatives may charge up to S\$4,500 in Service Fees per student.

The payment schedule of the Service Fee is as follows:

Phase 1: Upon application submission

50% of the Service Fee specified by the agency can be collected to cover administrative costs including document verification and translation services. Service fees paid at this phase are non-refundable.

Phase 2: Upon Immigration and Checkpoints Authority (ICA) Singapore's approval of Student's Pass Online Application & Registration (SOLAR+).

The remaining 50% of the Service Fee specified by the agency is to be collected. Service Fees paid at this phase are only refunded if the application for the Student's Pass is unsuccessful.
